Building, Zoning, Other, Sign Permits - Additional Requirements

1. Any structure under the jurisdiction of Kentucky Department of Housing and Building Construction shall have a Permit to Build Fee of \$.10/sf foot (\$25,000 Maximum Fee).
2. All Basement square footage shall be included in new Construction Permit Fees. Basements finished after original permit is closed will require a new Permit and Fee.
3. Double Permit Fees may be imposed for work started without a Permit.
